1. Statement of Commitment

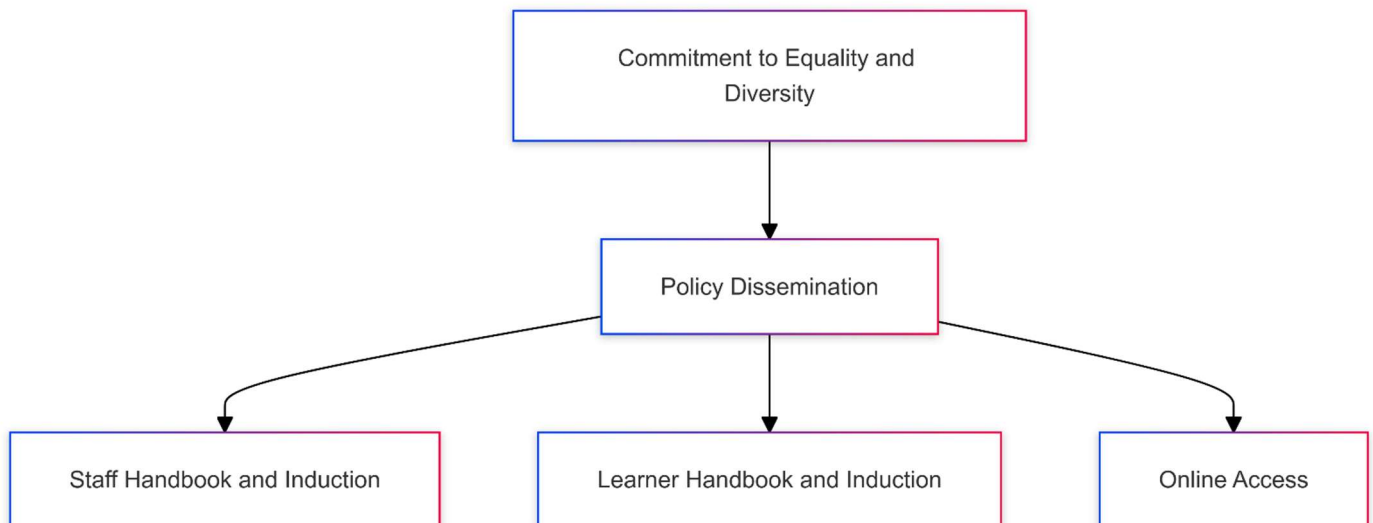

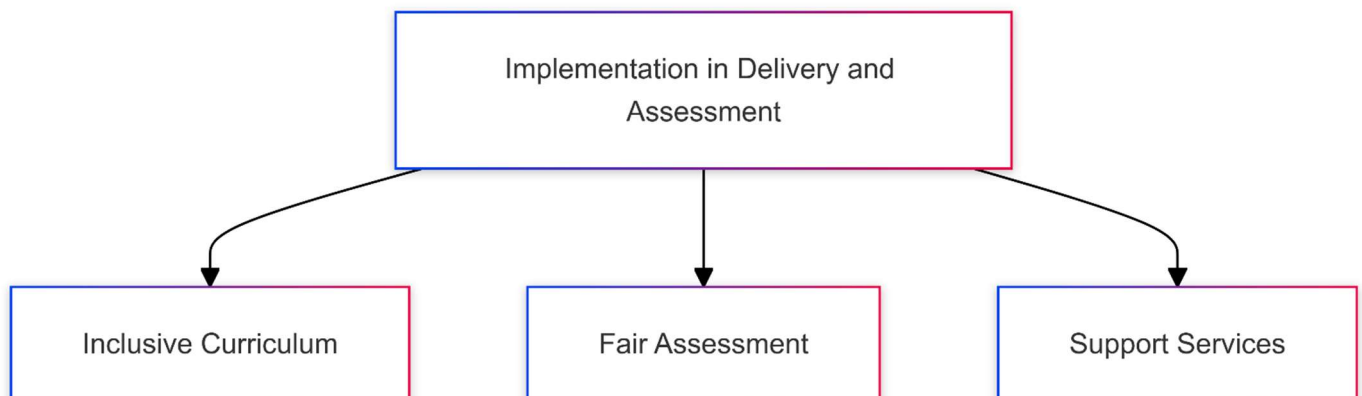
